I acknowledge:

A set of written operating instructions for the alarm system, including written guidelines on how to avoid false alarms, have been left with the applicant by the alarm installation company; and

Any false statement of a material fact made by an applicant for the purpose of obtaining an alarm permit shall be sufficient cause for refusal to issue a registration;

I understand that an alarm registration cannot be transferred to another person or alarm site, and that an alarm user shall inform the alarm administrator of any change that alters any of the information listed on the alarm permit application within five (5) business days of such change; and

All fines and fees owed by an applicant must be paid before an alarm permit may be issued or renewed.

INFORM YOUR ALARM COMPANY THAT THE NOTIFICATION NUMBER FOR FIRE, POLICE AND EMS IS (940) 349-1600. ALL ALARM CALLS MUST BE DISPATCHED THROUGH DENTON COUNTY SHERIFF'S OFFICE.

Your permit expires one (1) year from the date of issuance and must be renewed annually by submitting an updated application and registration fee to the alarm administrator. Failure to do so may result in non-response to alarms, the assessment of fines and penalties and a \$50.00 late fee if the renewal is more than 30 days after the expiration date.
