False Alarm Fee Schedule

Effective October 1, 2008

BURGLAR ALARMS

An alarm site is allowed 3 free false burglar alarms in 12 months. Within any 12 month period following the 3rd notification, a fee of \$50.00 is assessed for more than three (3) but fewer than six (6). \$75.00 is assessed for more than five (5) but fewer than eight(8). \$100.00 is assessed for more than eight (8).

FIRE ALARMS

An alarm site is allowed 2 free false fire alarms in 12 months. Within any 12 month period following the second notification, a fee of \$150.00 is assessed for each subsequent false fire alarm.

ROBBERY ALARMS

An alarm site is allowed 3 free false robbery alarms in 12 months. Within any 12 month period following the third notification, a fee of \$75.00 is assessed for each subsequent false robbery alarm.

EMERGENCY MEDICAL SERVICE ALARMS

An alarm site is allowed 2 free false emergency medical alarms in 12 months. Within any 12 month period following the fifth notification, a fee of \$50.00 is assessed for each subsequent false Emergency Medical Service Alarm.

FINANCIAL INSTITUTION ROBBERY ALARMS

Within any 12 month period following the third notification, a fee is assessed according to the following schedule.

4 th Alarm Notification	\$ 75
5 th Alarm Notification	\$100
6 th Alarm Notification	\$150
7 th Alarm Notification	\$200
8 th Alarm Notification	\$250
9 th Alarm Notification	\$300
10 th Alarm Notification	\$350
11 th Alarm Notification	Suspended
